High School & Ettinger Field:

700 North Second Street

Take Highway 494 to the 5th/7th Avenue exit. Go north on 5th Avenue to Marie Avenue. Go left on Marie to 9th Avenue. Go right on 9th to 3rd Street. Go right on 3rd, the field and high school will be on the right.

Central Square:

6th Avenue & 2nd Street

Take Highway 494 to the 5th/7th Avenue exit. Go north on 5th Avenue to Marie Avenue. Go left on Marie to 7th Avenue. Go Right on 7th Avenue. Pool building is on the right just south of the high school.

Harmon Field:

Spruce Street & Henry Avenue

Take Highway 494 to 5th Avenue. Go south on 5th to Spruce Street. Go left on Spruce to Henry Avenue. The field is on the right.

Lincoln Center:

9th Avenue & 3rd Street

Take Highway 494 to the 5th/7th Avenue exit. Go north on 5th or 7th to Marie Avenue. Go left on Marie to 9th Avenue. Go right on 9th to 4th Street. Go left on 4th to the parking lot.

McGuire Field:

3rd Avenue & 8th Street South

Take Highway 494 to 5th Avenue. Go north on 5th to 7th Street. Go right on 7th to 3rd Avenue. The field is on the left.

McMorrow Fields & Tennis Courts:

South Street & Henry Avenue

Take Highway 494 to the 5th/7th Avenue exit. Go south on 5th to South Street. Go left on South for three blocks. The fields and courts will be on the right.

Mississippi Dunes:

10351 Grey Cloud Trail, Cottage Grove, MN 55016

Take Highway 494 to Hwy. 61 South. Take the 80th Street/Grange exit and turn right. Take the first left (Hadley). Continue on Hadley until the road veers to the right (103rd). Go to Grey Cloud Trail and turn left. Follow signs to clubhouse.

North & South Fields:

3rd Street between 6th & 9th Avenues

Take Highway 494 to the 5th/7th Avenue exit. Go north on 5th to Marie Avenue. Go left on Marie to 6th Avenue. Go right on 6th to 3rd Street. Go left on 3rd to the fields. The North field is on the right (down in the "pit") and Southfield is on the left (at east end of the football field).

PAC/Kern's Courts:

Located next to the high school

Take Highway 494 to the 5th/7th Avenue exit. Go north on 5th to Marie Avenue. Go left on Marie to 8th Avenue. Go right on 8th and PAC/Kern's Courts is located straight ahead to the left of the

high school building. The entrance is on the lower level. PAC/Kern's Courts can also be accessed through the school for those choosing to park in the main parking lot on the east side of the school building. (This is the preferred entrance for the winter season.)

Roosevelt Fields & Tennis Courts:

5th Avenue & 5th Street

Take Highway 494 to the 5th/7th Avenue exit. Go north on 5th to 5th Street. The fields and courts will be on the right.

Southview Country Club:

239 E. Mendota Road, West St. Paul

Take Highway 52 South to the Southview Blvd./Mendota Rd. exit. Turn right on Mendota Rd. Continue on Mendota Rd. to the Southview Country Club.

Vet's Field:

15th Avenue & 3rd Street

Take Highway 494 to the 5th/7th Avenue exit. Go north on 5th to Marie Avenue. Go left on Marie to 15th Avenue. Go right on 15th to 3rd Street. The fields will be on the right.

Wakota Arena:

141 - 6th Street South

Take Highway 494 to Concord Street. Go north on Concord to 6th Street. Go left on 6th Street. Go up the hill and find the arena on the left.
