Use field complex and amenities at your own risk

To ensure a safe and well-maintained facility, the following articles and activities are PROHIBITED in ALL complex areas:

- Glass of any type
- Alcoholic beverages
- Smoking and use of smokeless tobacco products

Use of ISD 199 Spartan Stadium

- The following are prohibited on the turf:
 - All food and beverage products (except water) <u>including gum, and shelled seeds or nuts</u> (a serious allergy risk to others)
 - o Sharp objects such as tent stakes, corner flags, and poles that may penetrate or damage the turf
 - o Chairs or benches (these items may puncture the turf or cause damage)
 - o Portable heater and any open flame
 - o Metal cleats or high heeled shoes
 - o Dogs or Other Pets
 - o Any golfing or throwing activities such as hammer, shot, discus or javelin
 - o Suntan lotions, oils or creams of any kind Please apply sunblock prior to entering the turf area
- Always Lift and Carry (DO NOT DRAG) Goals and Equipment
- Use only goals/net specific to your sport. (Ex. Soccer balls should not be kicked at lacrosse nets, etc.)
- Please deposit all trash in trash receptacles PROVIDED

TURF FIELD SUPERVISION REQUIREMENTS

A Stadium Supervisor will be required and charged to the renting organization at \$20/hour (3 hour minimum) if any of the following criteria are met;

Renter needs access to run the scoreboard/PA system

- Renter would like to use the concession stand and/or outdoor restrooms
- Renter anticipates total attendance of over 500 people (spectators and participants)
- Renter requires Stadium lights on the weekend
- Renter requires use of our equipment (down markers, nets, pylons, etc.)

Custodial fees may be charged, in addition to Stadium Supervisor costs, at the discretion of the District, based on the size and needs of event.

Concessions/Advertisement/Signage:

Concessions

If you would like to serve Concessions at your event, we strongly suggest you go through our High School Booster Clubs. Please contact the Athletics Department or Community Education Department for more information.

Commercial Concessions Vendors

Approval for all outside, Commercial Food Vendors, must be made by ISD 199, at the discretion of the District, prior to rental. If you plan to have outside concession companies on site selling at the time of event (ex. Food trucks, mini-donut, popcorn, etc). You must notify the District at the time of rental. ISD 199 requires they have a current food vendor license from the State of Minnesota Department of Public Health. Groups who do not comply will not be allowed to serve food at the event and may result in termination of the permit.

Advertisement/Signage

All advertisements and signs that will be posted inside/outside of the building must be approved by ISD 199 prior to rental. ISD 199 restricts that use AND advertisement/sponsorship of all alcohol and tobacco on school grounds.

TURF FIELD USER'S RESPONSIBILITIES

Because the turf is not regenerated like natural grass, anything left on the turf remains there, posing health and safety hazards as well as general degradation of the turf. **Please clean up after your activity!!!**

Clean-up:

- 1. You are responsible to leave the field as clean and ready for the next user. When you are done, please inspect the field and remove anything left by your players or spectators, such as trash, athletic tape, or equipment. Be very careful to remove all mouth guards left by players (a biological hazard). Have your participants walk the field in a line at the end of their event.
- 2. Cleaning spills and participant fluids: Spills of foreign substances should be removed as quickly as possible. Thoroughly rinse any cleaning attempts to avoid slippery areas that could result in injury.
- 3. In the event that a user has left the fields without cleaning up or has allowed sunflower seeds and/or gum onto the field turf. A cleaning fee may be charged.
